**Re: Your Public Records Act Request Dated September 15, 2023**

Dear Mr. Stone:

This correspondence is in response to your Public Records Act request dated September 15, 2023 (“Request”). Helix Charter High School (“Helix”) has determined that your Request, in part, seeks disclosable records.

Helix is not required to create new records in order to provide you with the information that you seek. Moreover, the Public Records Act applies only to documents “prepared, owned, used, or retained by” Helix. (Govt. Code § 7920.530.) Further, Helix is not required to produce documents exempt from disclosure under the Public Records Act. (Govt. Code § 7922.000.) In responding to your request, Helix does not waive any further rights it may have to withhold records pursuant to the Public Records Act and relevant case law, and expressly reserves those rights. Lastly, please be advised that Helix also reserves the right to later supplement its production of documents should additional documents responsive to your request be located.

Dear Principal Lanz and Superintendent Ruhlman,

I am writing to express concerns over the last minute cancellation of the girls volleyball match between Helix and Christian High School that was to be held today at 6:15pm. It has come to my attention that your school notified us regarding the cancellation of the varsity girls game very late today before our team was going to board the bus to go to Christian for the volleyball match. Our athletic administrator and coaches were told that the junior varsity and novice games were okay to continue, but the varsity match was being cancelled for some vague reason.

Due to rumors related to why Christian officials cancelled the varsity match, our school needed to gather our student-athletes in our gymnasium to address the matter in support of our students' well-being. I would like to discuss this matter tomorrow to clarify the reason for the cancellation.

Today at approximately 1:30 pm, I received a text from our volleyball coach stating that she had heard that our volleyball varsity match vs. Christian had been canceled. We attempted to contact their coach and received no response.

At 2:09 pm I was able to reach Jeanette Benton in the Christian H.S. Athletics Office. I inquired about the status of the match and she said that the A.D., Jeff Briggs had sent me an email canceling the varsity match. I told her that I did not receive an email and would like to know why the match was canceled. She said that she would find the A.D. on campus and have him return my call.

At 2:24 pm Ms. Benton called back. She said that the Athletic Director was in meetings and could not return my call. When asked why the match was cancelled, she said they are "forfeiting because of circumstances they encountered with our team." I asked what circumstances they encountered, because we are not aware of any circumstances with our team? She said that she was "not privy to that information" and that Mr. Briggs would call me back when he was able to. I emphasized that I would appreciate a call back to this very important matter. I advised her that because the varsity match was being forfeited, we would not be sending the jv/frosh teams.

At 2:27 pm our coach received a text from Christian Coach Davis Ransom stating that "a situation has arisen that necessitates us forfeiting tonight's varsity volleyball match. I am sorry for the late notice."

Information that we received from parents is included in the attachments of text message conversations between myself and our coach, Zoe Varela-Beltz. We believe that Christian H.S. student-athletes, admin., and parents assumed that we have a transgender student on our team. We do not have a transgender student-athlete on our volleyball team and it should not matter if we did.

At no point did anyone from Christian H.S. reach out to any coach, administrator, or Athletic Director at Helix Charter H.S. regarding any concerns related to the cancellation of yesterday's match. Calls from myself to the Christian H.S. Athletic Director has yet to be returned.

We believe very strongly that this type of action by member schools violates the principles of what education based athletics are all about. We believe that there is no place for discrimination, hate, intolerance, bigotry in our society. The actions by Christian H.S. violate the CIF Code of Conduct and Six Pillars of Character, CA Law and Title IX.

We trust that you will handle this matter appropriately. Please let me know if I can be of any further assistance.

Hi Joe,

I just want you to know that I reached out to the Principal and Superintendent of Christian High School on Tuesday and Wednesday to have a phone conference to discuss why they forfeited the match just before our student-athletes were about to board the bus. In the past during, school officials have been very responsive in sharing the reason that have needed to cancel games or matches (ie. numerous injuries on a football team that necessitated the cancellation a few years ago and we have graciously accepted that reason from a smaller school program in the past). However, I have never had school officials not respond and be forthright as to why they needed to cancel a game or match.

We suspected it is for one of the reasons circulating in the community; however, we have no direct evidence as to the actual reason that they canceled the match. If we receive any evidence, we will forward it to CIF. Either way, we deserve an explanation as to why we were notified about the forfeiture last minute which caused our student-athletes to miss an athletic opportunity they deserved to have. If evidence is uncovered that the reason for cancellation is related to gender or sexual orientation issues, then we hope the CIF takes appropriate actions to ensure that this does not happen to the student-athletes of other member schools.

Thank you for your efforts to do the right by our student-athletes and member schools.
